#### 2.0 Social media serves as a communication channel

According to Greenhow and Lewin (2016), educators thought that the communication between educators and peers can be increased and peer tutoring and peer feedback can be enabled. In addition, students were capable of sharing their knowledge and learning with one another as well as with educators and pupils from other institutions. It is a significant and positive learning consequence, as well as a basic tenet of democracy (Rheingold, 2008). In our point of view, through collaborative platforms, students who have low self-esteem can also boost their confidence level as they can comfortably share their opinions and ideas in social media.

#### 4.0 Social media provides a variety of study materials

In the network, we can use many social media platforms to find information and study materials. Information in social media is of various sorts and varieties.
