#### 1.0 INTRODUCTION

In general, referencing means a way of someone gives credit to us in using their ideas or thoughts when doing research. Good referencing includes attention to detail such as correct page numbering, the spelling of the author's names and the accuracy of relevant facts that will be stated in the paper (Santini, 2018). It is important to enabling us to get information about the original sources of the ideas or thoughts that we have used in research and also help to avoid plagiarism. The referencing system provides the reader with an indication of the quality and authority of the material you are referencing. The referencing system gives supporting evidence to certain facts that we use in the text. It has two parts of referencing which are the citations in a text and the reference list at the end of the research.

There are some important factors that we need to include while using referencing system:

- The name of the author
- Date of publication
- Name and location of the publishing company
- Title of the journal or name of the book
- Title of the research or chapter's name
- DOI (Digital Object Identifier)

### 2.0 CITATION AND REFERENCE LIST WRITING BASED ON APA REFERENCING SYSTEM

APA referencing system is always used in academics including nursing, psychology and economics. The purpose of the APA referencing system is to standardize scientific writing and enhance our paper's organization.

#### 2.1 CITATION WRITING BASED ON APA REFERENCING SYSTEM

APA referencing system is known as "author-date" style, which contains the author(s) and the year of publication given wholly or partly in round brackets in-text citation. It is generally used when we quote some comment in our assignment. When in-text citation, use only the surname of the author(s) followed by a comma and the year of publication. It can be included page, chapter or section numbers if we need to be specific.

#### 2.2 REFERENCE LIST WRITING BASED ON APA REFERENCING SYSTEM

A reference list means a complete list of references used in a writing that consists the author name, date of publication, title and more. Reference list entries contain all the information that is required to follow up our source. It needs to be arranged alphabetically by author. Referencing list must be centred and be on a new page at the end of the document. There is no distinction is made among books, magazines, journal articles, internet documents or other formats except for electronic documents that do not provide page numbers.

## 3.0 CITATION AND REFERENCE LIST WRITING BASED ON HARVARD REFERENCING SYSTEM

Harvard referencing system is a popular format that commonly used in assignments and publications for humanities. It makes the readers understand how we did our research and allows us to acknowledge the contribution of other authors in our research.

#### 3.1 CITATION WRITING BASED ON HARVARD REFERENCING SYSTEM

HARVARD REFERENCING SYSTEM generally shows the last name of the author and the year the source was published. It contains the author(s)'s or editor(s)'s surname, year of publication and page number(s).

In case we quote directly from an author or to cite a specific idea or information from the source we need to consist the page number of the quote in our in-text citation.

## 3.2 REFERENCE LIST WRITING BASED ON HARVARD REFERENCING SYSTEM

Reference list in Harvard referencing system includes information about the sources like the author, date of publication, title of the source, city published, publisher and more. It must be listed in alphabetically author. Referencing list must be on a new sheet at the end of the document.
